INSTRUCTIONS FOR FILING A PEDDLER / SOLICITOR / SERVICE LICENSE APPLICATION

No person shall, without first obtaining a license to operate, act or attempt to act within the unincorporated area of the County of San Joaquin as a peddler, solicitor, or a service provider. To procure a license to operate, a written application must be filed with the San Joaquin County Treasurer-Tax Collector (TTC).

Before the TTC may issue a solicitor or service license, the applicant must file with the TTC a bond in the amount not less than \$1,000.00 executed by an established surety company. Bond shall remain in effect for 30 days after the expiration of a license or any renewal thereof.

The TTC shall issue a license to the applicant upon the filing of an application for license, the posting of the required bond, the investigation of the information contained in the application by the Sheriff's Office, including the applicant's business background and moral character, and the Sheriff's favorable report. A \$35.00 background check fee will be collected separately by the Sheriff's Office. Should the Sheriff report that any of the information in such application is untrue or that the applicant's character or business responsibility is unsatisfactory, the TTC shall notify the applicant that the application has been denied and that no license will be issued.

A soldier, sailor or marine who has received from the United States an honorable discharge or release from active duty under honorable conditions, and who wishes to obtain a license, is exempt from any and all license fees.

The following items are required for peddler, solicitor, or service licenses:

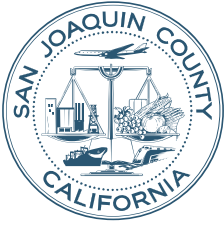
1. Peddler, solicitor, or service license application
2. Government issued identification or driver's license (if operating a motor vehicle)
3. General liability insurance with declaration sheet
4. Environmental Health permit if edible items are being sold
5. Surety bond of \$1,000.00 for solicitor or service licenses
6. Non-refundable \$180.00 license fee payable to San Joaquin County Treasurer-Tax Collector or SJC
TTC

Bring items listed above to the TTC's Office. The TTC will then submit your application to the Sheriff's Office. Applicants will have a background check administered and be fingerprinted by the Sheriff's Office during the hours of 8:00 a.m. - 12:00 p.m. and 1:00 p.m. - 4:00 p.m. Monday, Wednesday, and Friday (excluding holidays). Upon approval from the Sheriff's Office, applicants will be notified to return to the TTC's Office to have a photo identification taken. The TTC will furnish a license and identification card valid for one year. Any licensee must carry on his or her person at all times their license identification card and it must be shown for business purposes. Peddlers must display their license at all times in a conspicuous place at the dispensing location. No peddler shall dispense any merchandise not listed on his or her license.

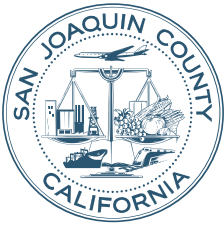
