Please be advised that the San Joaquin County Environmental Health Department Solid Waste Local Enforcement Agency (LEA) received and has approved a Report of Facility Information (RFI) amendment to the Solid Waste Facility Permit for the Forward Inc. Landfill. The LEA is certified by the California Integrated Waste Management Board (CIWMB) to enforce state law and regulations at the solid waste sites within the County of San Joaquin, excluding the City of Stockton, including all active and closed landfills.

### Description of the Project and the LEA's Determination

The Forward Inc. Landfill is a permit 567-acre existing landfill site located at 9999 S. Austin Road, Manteca. On May 21, 2008, the LEA received the propose amendment from the Forward Inc. Landfill a Solid Waste Facility Permit (SWFP) application package to amend the RFI requesting that Appendix A and L be amended. The application was accepted as incomplete on June 20, 2008, and accepted as complete on August 20, 2008. Appendix A was amended to include updated Waste Discharge Requirements and San Joaquin Valley Air Pollution Control District permits. Appendix L, the Preliminary Closure Post Closure Maintenance Plan, was amended to provide a Closure Cost Estimate that is consistent with Title 27 California Code of Regulation, Sections 21815 and 21820. There are no other changes to SWPF under consideration at this time.

The LEA finds that the proposed change is consistent with all applicable certified and/or adopted CEQA documents, is consistent with State Minimum Standards, and does not conflict with the terms and conditions in the current solid waste facilities permit. The LEA approved the amendment on August 20, 2008.
