**NAME:** CHILDREN'S SERVICES COORDINATING COMMISSION

**COMPENSATION:** None.

**LEGAL AUTHORITY:** Established by Board Order B-86-1705 adopted September 23, 1986; Expansion of Membership by Board Order B-89-1084 adopted August 1, 1989; Transfer of Staff Support from Department of Aging to San Joaquin County Office of Education by Board Order B-94-12 adopted January 4, 1994; Modification of Membership by Board Order B-99-322 adopted March 22, 1999; and Designation of the Children's Service Coordinating Commission to Serve as the Child Abuse Prevention Coordinating Council in Compliance with Chapter 12.5 of the California Welfare and Institutions Code and to Administer the County Children's Trust Fund per California Welfare and Institutions Code 18965 et seq by Board Order B-05-742 and Resolution R-05-372 adopted June 28, 2005.

- 9) 1 Licensing Agency Representative
- 10) 1 District Attorneys Office Representative
- 11) 1 Coroner Representative
- 12) 1 Civic Organization Representative
- 13) 1 Religious Community Representative
- 14) 1 or more Community Volunteer Representatives
- 15) 1 or more Consumer Representative

**TERM:** 3 Year Terms.

- DUTIES:**
1. Provide a forum for interagency cooperation and coordination in the prevention, detection, treatment, and legal processing of Child Abuse cases.
  2. Promote public awareness of the abuse and neglect of children and the resources available for intervention and treatment.
  3. Encourage and facilitate the training of professionals in the

detection, treatment and prevention of child abuse and neglect.

4. Recommend improvements in services to families and victims.
5. Encourage and facilitate community support for child abuse and neglect programs.
6. Introduce and monitor legislation pertaining to children.
7. Conduct needs assessments and identify gaps in services.
8. Spearhead community education on the needs of children.
9. Make recommendations on the allocation of Promoting Safe and Stable Families, Child Abuse Prevention, Intervention, and Treatment, and Community-Based Child Abuse Prevention funds.
