San Joaquin County, in conjunction with the cities of Escalon, Lathrop, Manteca, Ripon, and Tracy is updating its Consolidated Plan. The Consolidated Plan will describe how the County intends to spend Federal housing and community development entitlement funds during the next five years (2015-2019). The County received Community Development Block Grant (CDBG), HOME Investment Partnerships Program (HOME), and Emergency Solutions Grant (ESG) funds. The funding must benefit low and moderate-income persons.

The County welcomes your input about the community's housing, economic, and social service needs, and on how to spend Federal entitlement funds to benefit the communities in the county.

The Community Development Department is hosting two public Focus Group meetings on **March 19, 2015**. The morning meeting (**10 a.m**.) will focus on institutional concerns of non-profits, faith-based groups, service providers, schools, and government agencies. The afternoon meeting (**2 p.m**.) will focus on issues related to housing, businesses, and economic development.
