Notice of Public Comment Period for Draft 2018-2019 Annual Action Plan

San Joaquin County has prepared a draft of the 2018-19 Annual Action Plan, which details specific projects to be funded with U.S. Department of Housing and Urban Development (HUD) funding allocated to San Joaquin County and the cities of Escalon, Lathrop, Manteca, Ripon, and Tracy. The projects detailed in the draft plan are to be funded with 2018-19 allocations of Community Development Block Grant (CDBG), Emergency Solutions Grant (ESG), and HOME Investment Partnership Program (HOME) funds. The projects scheduled for funding will address housing and non-housing community development needs identified in the County's 2015-2019 Consolidated Plan.

The County's 2018-2019 estimated allocation of HUD resources are: \$2,469,366 of Community Development Block Grant (CDBG) annual allocation; \$917,408 in CDBG Program Income; \$795,219 of HOME Investment Partnership (HOME) annual allocation; \$963,000 in HOME Program Income; and \$213,082 of Emergency Solutions Grant (ESG) funds. These totals are only estimates as exact allocations have not been released yet. The Action Plan describes how the projects and funding amounts will be adjusted based on official figures provided by HUD.

A public hearing will be held at the Board of Supervisors meeting in the Board Chambers on the sixth floor of the County Administration Building, 44 N. San Joaquin Street, Stockton, CA on May 8, 2018 at 10:00 AM to solicit any additional public comments regarding the information and projects identified in this Plan.
