The San Joaquin County Environmental Health Department is proposing an adjustment of Environmental Health operating permit and hourly rate service fees for retail food establishments and operations located in San Joaquin County. The proposed fee changes would take effect on August 1, 2009.

A morning meeting to discuss these proposals with food facility owners and operators and representatives of the retail food industry, as well as members of the general public, has been set for **Thursday, May 14, 2009, at 9:00 a.m.** The meeting will be held at the San Joaquin County Environmental Health Department office located at **600 E. Main Street (corner of Main and American Streets), Stockton, California.**

Proposed changes in program fees are included with this notice and will be discussed at the meeting. This opportunity for public and industry comment is being provided in preparation for the public fee hearing to be held before the San Joaquin County Board of Supervisors, tentatively scheduled for **June 25, 2009**, in the Board Chambers, 7th Floor of the County Courthouse, 222 E. Weber Avenue, Stockton, California.

The second portion of the workshop will be dedicated to a demonstration of the proposed Online Food Facility Inspection Search Page. The department is planning to begin posting food facility inspection results on the Environmental Health website, as has been done in several cities and

counties throughout California. This additional point of access for reviewing these public records will provide the community with the convenience of online review of food facility inspections. This is an opportunity for the public and affected businesses to comment on the proposed online search page prior to its implementation.
