### Course Description

This International Critical Incident Stress Foundation-certified CISM: Group Crisis Intervention course is designed to assist personnel from hospital, clinics, long term care facilities, and pre-hospital care providers in developing a CISM team and offering services. The three-day course prepares peer support personnel and mental health professionals to provide a **variety of crisis intervention services** for distressed individuals following traumatic events including job or family-related incidents, natural disaster or terrorism. The services include pre-incident education, defusings, the Crisis Management Briefing, debriefings, and peer support, among others. Attendees will receive a **Certificate of Completion from the ICISF** in Baltimore, Maryland.
