- PG&E Utility Bill Pages 1 & 3
- City of Lodi Utility Bill (Complete)
- Bill or Statement from Propane Company
- Copy of Rent Receipt or Letter from Landlord showing utility portion of rent (Sub-Metered)
- FOR ECIP: PG&E Account Information Sheet; Delinquent *plus* regular bill for all other companies
