TENANT UPDATE – NOVEMBER 2009

SECURITY CONCERNS:

We were recently notified that some of our Air Metro Business Park tenants have experienced break-ins. Airport Police and the San Joaquin County Sheriff's Department is aware of these events. We have increased our security patrols in these areas and have contacted PG&E to ensure that all of the street lights in the area are working properly. We encourage you to check the lights around your buildings and parking areas. Consider adding security cameras or motion-sensor lights. Please contact the San Joaquin County Sheriff's Office immediately if you witness any unusual activities.

COUNTY AVIATION ADVISORY COMMITTEE MEETING:

On November 24, 2009, the San Joaquin County Board of Supervisors (BOS) approved the announcement of seven (7) positions on the Aviation Advisory Board. The Aviation Advisory Board generally meets once per month in the Airport's Aviation Conference Room, on the 4th Tuesday of each month beginning at 5:00 p.m. The purpose of the committee is to provide for citizen input in the policy areas of developing aviation, make recommendations to the BOS on major airport projects, and assists in the promotion of the airport and aviation services to the community. The Committee will also act as the Master Plan Advisory Committee and will develop an annual report and a strategic plan for the airport.
