**PROJECT DESCRIPTION:** A Minor Subdivision application to subdivide an existing 58.99 acre parcel into 2 parcels. Parcel 1 to contain a 4.50-acre homesite parcel and will be serviced by an existing well for water, existing septic system for wastewater, and natural onsite drainage for storm water. Parcel 2 to contain the remaining 54.50-acres, with a well for water to support an existing agricultural production use, natural onsite drainage for storm water, with no proposed wastewater facilities. Parcel 1 and 2 will both have direct access from North Cox Road. The site is currently under a Williamson Act contract.

The Property is zoned AG-40 (General Agriculture, 40-acre minimum) and the General Plan designation is A/G (General Agriculture).

**PROJECT LOCATION:** The project site is on the east side of North Cox Road, 1,325 feet south of East Comstock Road. (APN/Address: 091-240-12 / 6840 N. Cox Rd., Linden) (Supervisorial District: 4)

**ENVIRONMENTAL DETERMINATION:** This project as described is exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15061 (b)(3), and a Notice of Exemption will be filed if the project is approved.
