## Annual Action Plan Substantial Amendment #1 for FY 2017-2018

In accordance with the County of San Joaquin's Citizen Participation Plan and the requirements of the U.S. Department of Housing and Urban Development (HUD), a public comment period is being circulated to solicit public comments and questions regarding the Annual Action Plan Amendment. The purpose of this comment period will be to provide the public an opportunity to comment on the Annual Action Plan Substantial Amendment #1 for 2017/2018. The substantial amendment will result in the allocation of funds to new projects that were not previously identified funded through prior year resources and the commitment of additional CDBG/HOME Program Income dollars to new projects to ensure the integrity of the County's expenditure obligations.

A public hearing will be held at the Board of Supervisors meeting in the Board Chambers on the sixth floor of the County Administration Building, 44 N. San Joaquin Street, Stockton, CA on May 8, 2018 at 10:00 AM to approve this amendment and solicit any additional public comments.

The County of San Joaquin proposes to allocate funding to the following projects listed below. The total funds to be allocated/re-allocated will be approximately \$3.3 million in CDBG funds and \$350,000 in HOME funds. The new projects/increases are as follows:

- 1. Acampo Area Drainage Project -\$1,408,058 (CDBG Program Income)
- 2. Roselawn Multi-Family Housing Project \$936,000 (CDBG Program Income) & \$350,000 (HOME Program Income)
- 3. STAND Housing Acquisition/Rehabilitation \$1,315,000 (CDBG Program Income)
- 4. East Stockton Storm Drainage Improvements \$133,500 (CDBG Program Income)
- 5. Manteca Cottage Village Senior Apartments \$60,000 (CDBG Prior Year Resources)
- 6. Manteca Senior Center Improvements \$555,307 (CDBG Prior Year Resources)
- 7. Ripon Pine Street/McKee Court Handicap Ramps \$164,491 (CDBG Prior Year Resources)
- 8. Ripon Senior Center Parking Lot Project \$38,000 (CDBG Prior Year Resources)
