**DECLARATION OF LOCAL HEALTH EMERGENCY
(Health & Safety Code §101080)**

WHEREAS, California Health and Safety Code Section 101080 authorizes a local health officer to proclaim a local health emergency in the health officer's jurisdiction, or any part thereof, whenever the health officer reasonably determines that there is an imminent and proximate threat of the introduction of any contagious, infectious, or communicable disease, chemical agent, noncommunicable biologic agent, toxin, or radioactive agent, and

WHEREAS, on January 30, 2020, the World Health Organization declared the outbreak of a Novel Coronavirus Disease (COVID-19) a "public health emergency of international concern", and on March 11, 2020 referenced the event as a pandemic; and

WHEREAS, on January 31, 2020, United States Health and Human Service Secretary Alex M. Azar II declared a public health emergency for the United States to aid the nation's healthcare community in responding to COVID-19; and

WHEREAS, the Centers for Disease Control and Prevention announced on February 25, 2020, that community spread of COVID-19 is likely to occur in the United States, and

WHEREAS, March 4, 2020, the Governor of the State of California Proclaimed a State of Emergency, which included waiving the 30-day time period requirement for renewal of a local health emergency for the duration of the statewide emergency; and

WHEREAS, there is currently three (3) confirmed case of COVID-19 in San Joaquin County, and there is an ongoing risk and likelihood of COVID-19 patients being identified in San Joaquin County; and

WHEREAS, the San Joaquin County Public Health Services will use all preventive measures, which requires access to available services, personnel, equipment, and facilities, to respond to COVID-19; and

WHEREAS, this declaration enables the County to more effectively respond to the outbreak, seek and utilize mutual aid, potentially obtain reimbursement, and ensure that the County's public health professionals and providers have all necessary personal protective equipment to provide quality care and keep our community safe.

NOW, THEREFORE, the San Joaquin County Health Officer declares and proclaims a local health emergency in San Joaquin County commencing on or about 9:30 a.m. of the 12th day of March, 2020.

SAN JOAQUIN COUNTY PUBLIC HEALTH OFFICIALS ANNOUNCE TWO NEW CONFIRMED POSITIVE CASES OF COVID-19 AND DECLARE A PUBLIC HEALTH EMERGENCY

*NOW WITH THREE CASES OF COVID-19 IDENTIFIED IN SAN JOAQUIN COUNTY,
RESPONSE EFFORTS SHIFT TO COMMUNITY MITIGATION MEASURES THAT WILL SLOW
THE SPREAD OF COVID-19 IN THE COMMUNITY*

STOCKTON, CA (March 12, 2020) – San Joaquin County Public Health Services (PHS) confirmed today that two (2) additional county residents have tested positive for the Coronavirus disease 2019 (COVID-19), bringing the total to three (3). Contact tracing investigations have begun to identify possible exposures, monitor for symptoms and limit the spread of the illness. Public health officials are implementing crucial measures to reduce the spread of COVID-19 in the community.

Today PHS declared a Local Public Health Emergency in order to assist in leveraging additional resources and funding to ensure an appropriate response to the COVID-19 outbreak. The proclamation should not be considered a reason for heightened concern; it is intended to help facilitate additional resources to address the increasing demands of containing the virus.

With the likelihood of additional cases of COVID-19 in San Joaquin County, health officials also announced today that public health response efforts will now focus on community mitigation measures, which means moving from more individually focused, labor-intensive “contact-tracing” and quarantine, to minimizing the impact of COVID-19 in the greater community. These actions are important steps to freeing up public health resources to protect the most vulnerable populations, and allow our health care system to prepare for taking care of severely ill patients.

Health officials continue to advise county residents to follow prevention guidelines for COVID-19 and other respiratory diseases that include:

- Washing your hands often with soap and water for at least 20 seconds. If soap and water are not readily available, use an alcohol-based hand sanitizer.
- Avoiding close contact with people who are sick.

- Avoiding touching your eyes, nose, and mouth.
- Staying home when you are sick.
- Covering your cough or sneeze with a tissue, then throwing the tissue in the trash.
- Cleaning and disinfecting frequently touched objects and surfaces using a regular household cleaning spray or wipe.
