 - i. Crop Report coming out next month.
 - ii. Val Dolcini the DPR Director resigned, Julie Henderson from CalEPA is temporarily taking his spot and Karen Morris is taking Jesse Cuevas spot.
 - iii. Meetings in two weeks regarding pesticide applications notifications with group of commissioners. State wide program notifying people of applications.

 - vi. Eyewash decontamination units in line with Fed is open for comment.

- i. 15-year ordinance, working last two years on ordinance. Existing ordinance adopted in 2006. Collaboration between agriculture and building community. Ag piece of property zoned for Ag any time zones change Ag mitigation kicks in. In 2008, development came to a standstill and re-convened as a committee in 2013 or 2014 and starting working on creating an Agricultural easement document. The other alternative was to pay an in-lieu fee, a fee that was set by the Board of Supervisors based on fair market value. A project from Truck Stop, they were the one entity that went to BOS to ask to pay an in-lieu fee, and was granted. There has not been a lot of development that has required Ag easement. Ordinance prefers easement as oppose to paying a fee. The ordinance never really got anywhere and has multiple issues.
