Project Location - Specific: The project site is on the south side of W. Mathews Road, 600 feet west of S. Manthey Road, French Camp. (APN/Address: 193-190-13 / 202 W. Mathews Rd., French Camp) (Supervisorial District: 3)

Project Description: Conditional Use Permit application to expand an existing 5.93-acre cemetery onto the adjacent 3.9-acre parcel to allow for additional gravesites. An additional 28 parking spaces and a 147-square-foot restroom are also proposed. The expansion area will be accessed from the existing driveway on Manthey Road and two new driveways on the existing private road, South Grove Tree Road, that runs along the western property line. The project will be served by private on-site services for water, sewer, and stormwater drainage. (Use Type: Funeral/Interment Services - Cemetery)

The Property is zoned AL-10 (Limited Agriculture, 10-acre minimum) and P-F (Public Facilities); the General Plan designation is AUR (Agricultural-Urban Reserve).
