Project Description/Location: The City of Stockton's Public Works Department will be installing left turn lane improvements at Harding Way and Lincoln Avenue on the eastbound and westbound approaches, and at Harding Way and Pacific Avenue/Madison Avenue on the eastbound and westbound approaches. The project will also include signal upgrades, cabinet appurtenances, pedestrian countdown signal heads, wheelchair ramp accessibility improvements in accordance with ADA standards, and high friction surface treatment on thru approaches. 
- The activity is not a "project" as defined in CEQA Guidelines Section 15378.


