RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANTECA, STATE OF CALIFORNIA, APPROVING PLANS AND SPECIFICATIONS FOR THE WOODWARD PARK SPLASH PAD – PHASE II RESTROOM RELOCATION (CIP 24086), APPROVING THE CALIFORNIA ENVIRONMENTAL QUALITY ACT NOTICE OF EXEMPTION DETERMINATION, AUTHORIZING A CALL FOR BIDS, AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO TAKE ALL APPROPRIATE ACTIONS NECESSARY TO CARRY OUT THE PURPOSE AND INTENT OF THE RESOLUTION (EXEMPT FROM CEQA PURSUANT TO 14 CAL. CODE REG. § 15301(E))

WHEREAS, Plans, Specifications and Estimate for the Woodward Park Splash Pad – Phase II Restroom Relocation (CIP 24086) are complete and available for review in the Public Works Department - Park Operations Office; and

WHEREAS, In addition to the splash pad project, the Phase II work will include relocation of the existing premanufactured restroom building, along with various improvements, such as pad and utility preparation for existing premanufactured restroom building, demolition of existing features, new low retaining wall, fencing, improved walkways, utility connections (sewer and water), and electrical work.

WHEREAS, staff has reviewed and determined that the project is Categorically Exempt under the California Environmental Quality Act (CEQA) based on Article 19 Section 15301(e), Class 1 “Existing Facilities”; and

WHEREAS, a Notice of Exemption will be filed with the San Joaquin County Clerk/Recorder and the State Clearinghouse for the Project pursuant to 14 Cal. Code Regs. § 15094; and

WHEREAS, the City Council has considered all information related to this matter, as presented at the public meetings of the City Council identified herein, including any supporting reports by City Staff, and any information provided during public meetings.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Manteca, as follows:

- 1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct, and establish the factual basis for the City Council's adoption of this Resolution.**

2. The City Council hereby approves the Plans, Specifications and Estimate for the Woodward Park Splash Pad – Phase II Restroom Relocation (CIP 24086)
3. The City Council hereby approves the California Environmental Quality Act Notice of Exemption determination for the Project.
4. The City Council hereby accepts the Invitation to Bid for the Woodward Park Splash Pad – Phase II Restroom Relocation and hereby instructs the City Clerk to sign same.
5. This Resolution shall take effect immediately upon adoption.


