**PROJECT TITLE:** Conditional Use Permit No. PA-2600014

**PROJECT LOCATION:** The project site is on the south side of East Lone Tree Road, approximately 2,025 feet west of South Due Road, in the City of Escalon., San Joaquin County. (APN/Address: 203-110-19 / 15200 E. Lone Tree Rd., Escalon) (Supervisory District: 4)

**PROJECT DESCRIPTION:** Conditional Use Permit application for a 4,043.52-kilowatt (kW) DC STC ground-mounted photovoltaic system occupying approximately 14.47 acres. Site access will be provided via an existing driveway located at the south end of East Lone Tree Road, a County-maintained roadway, as well as a proposed fire access road. The project site will be served by existing private water, stormwater, and septic systems. The parcel is currently subject to a Williamson Act Contract.

The Property is zoned AG-40 (General Agriculture, 40-acre minimum) and the General Plan designation is A/G (General Agriculture).

**PROPONENT:** Jordan W. Jones / California Solar Innovators
