PROJECT TITLE: Administrative Use Permit No. PA-2400335 (A)

**PROJECT LOCATION:** The project site is located south of West Schulte Road, 3,116 feet west of South Lammers Road, Tracy, San Joaquin County. (APN/Address: 209-240-32 / 14950 W. Schulte Rd., Tracy) (Supervisorial District: 5)

PROJECT DESCRIPTION: Administrative Use Permit application to develop a 40 megawatt (MW), 8-hour duration, 320 MW hour battery energy storage system (BESS) project on approximately 12.8 acres within a 39-acre parcel that is adjacent to the Tracy combined cycle power plant (TCCPP). The project will consist of modular battery and inverter enclosures, transformers, switchyard, short 115 kilovolt gen-tie line, water line, and ancillary facilities. This property is not under Williamson Act contract.

The Property is zoned AG-40 (General Agriculture, 40-acre minimum) and the General Plan designation is A/G (General Agriculture).
