Project Description/Location: The City of Stockton's Public Works Department will be rehabilitating an existing 24" large diameter sewer line approximately 424-feet long, with associated maintenance holes, along Fischer Court between I-5 and Plymouth Road, as well as rehabilitating an existing 42" large diameter sewer line approximately 1,311-feet long and associated maintenance holes across the Union Pacific Railroad between El Dorado Street and Perlman Drive.
