Description of Nature, Purpose and Beneficiaries of Project:

Proposed project would replace existing dilapidated pile-guided boarding float and gangway with a dedicated low-freeboard dock to accommodate non-motorized watercraft users at the Louis Park Boat Launching Facility. After completion, the proposed project will serve as a hub for recreational non-motorized boating, enhancing public access, safety, and community tourism. The proposed project also includes the installation of a new gangway, gangway abutment, concrete walkway, and Americans with Disabilities Act (ADA)-compliant parking stall. No dredging would be required as part of the proposed project.
