This request is for you to inform the Assessor of any change in ownership, mailing address, and location or condition of your vessel/watercraft to insure the proper owner receives the correct allocation of property taxes.

Vessels are assessed annually to the owner of record as of January 1. A tax bill in your name will be issued in July (approximately 1% of the assessed value), and assessments are **NOT PRO-RATED.** By law, the sale, removal or loss of property **after** January 1 does not relieve the owner of the property tax liability and in order to cancel the assessment, you must submit proof that the indicated change occurred prior to January 1. NO RESPONSE IS NECESSARY IF INFORMATION IS CORRECT. If you have questions, call (209) 468-2630.
