Re: SB 1392 (Cortese) – Smog check: exemption: collector motor vehicles. – Support (as amended)

Dear Chair Cervantes,

I am writing to inform you of my support for SB 1392, which aims to modernize smog check exemptions for classic and collector motor vehicles. I previously supported SB 712 and appreciate these efforts on behalf of California car enthusiasts and a culture and industry that fuels our state's economy.

According to the Specialty Equipment Market Association (SEMA), the aftermarket industry alone generates more than \$40 billion in economic impact, supporting approximately 150,000 jobs, \$14 billion in wages and benefits, and \$6 billion in taxes.

SB 1392 would redefine collector motor vehicle to mean a vehicle that is at least 35 years old, is used primarily in shows, parades, charitable functions, and historical exhibitions, is not used as the owner's primary mode of transportation, and is insured as a collector motor vehicle, as specified. The bill would exempt a collector motor vehicle manufactured before the 1981 model year from the requirement to obtain a certificate of compliance or noncompliance and, provides a pathway for qualifying collector vehicles to receive relief from the state's biennial smog check requirement, requires collector-vehicle insurance with proof at registration, and phases in eligibility by one model year each year, beginning January 1, 2028, until the final extension takes effect on and after January 1, 2032.

This exemption addresses challenges classic car owners face. Maintaining compliance is increasingly difficult as fewer smog stations are equipped to test older vehicles. According to SEMA, only 7% of California smog checks are performed on pre-OBD-II vehicles, and many STAR-certified stations test fewer than one of these vehicles per day, making it cost prohibitive for smog shops to maintain the specialized equipment needed to test older vehicles.

For those who have a passion for restoring classic or vintage vehicles, California's stringent testing requirements often require expensive modifications that may compromise the historical authenticity of these automotive gems. These hurdles have led many enthusiasts to relocate to more car-friendly states like Arizona, Texas, and Nevada.

SB 1392 (CORTESE) – SMOG CHECK: EXEMPTION: COLLECTOR MOTOR VEHICLES. – SUPPORT (AS AMENDED)
