## Pacific Gateway Project Draft Environmental Impact Report (EIR)

Public comment period for the Gateway Project Draft EIR closed December 22, 2025. More than 30 public comments and 12 agency letters were received on the Draft EIR, including from the City of Tracy, San Joaquin LAFCo, Caltrans, Farm Bureau, Stanislaus COG, Sierra Club, as well as several law firms.

### Next steps for the project include:

- Review of comments received on the Pacific Gateway DEIR by the project EIR consultant, and completion of a Final EIR;
- Scheduling a noticed public hearing before the County Planning Commission, who would make a recommendation on certification of the EIR documentation and project application entitlements to the County Board of Supervisors; and
- Scheduling a noticed public hearing before the Board of Supervisors for consideration of EIR certification and action on the project.

## Documents and Updates

- No public hearing dates have been set at this time. Updates will be shared as they become available.
- Staff anticipates commencing with a Planning Commission hearing as soon as Summer 2026.

# LEGISLATIVE ADVOCACY: MAKING YOUR VOICE HEARD



## Appeals Court Shoots Down California Water Managers' Plan to Finance Delta Tunnel

I am encouraged by the recent decision from the California Third District Court of Appeal, which confirmed that the Department of Water Resources does not have the legal authority to issue billions of dollars in bonds for the proposed Delta tunnel project without explicit legislative approval.

As a member of the Delta Counties Coalition, San Joaquin County fought for and supports this ruling. This decision is an important step in protecting our local communities and ensuring that large-scale projects like the Delta tunnel are subject to proper oversight and accountability. ## Pacific Gas and Electric Company's (PG&E) 2027 General Rate Case (GRC)

Last year, I wrote – [letter can be viewed here](#) – to the California Public Utilities Commission (CPUC) to express opposition to PG&E's 2027 GRC application to increase revenues to cover natural gas and electric operations, distribution, and generation costs for 2027–2030 and urged that they reject it.

At my request, the San Joaquin County Board of Supervisors formally urged the CPUC to reject PG&E's proposed rate increase scheduled for January 1, 2027. Since 2021, PG&E rates have risen nearly 40%, putting added pressure on local households. With a per capita income \$10,000 below the state average, many residents face difficult choices between essential needs like heating, cooling, and prescriptions. In 2022-2023, the County provided \$7.3 million in emergency utility assistance to over 6,300 low-income households. The Board emphasized that utility rates must remain "just and reasonable" and called on PG&E and the CPUC to prioritize the community's needs over profits.

I have worked on establishing a collaborative relationship with PG&E and its staff while continuing my efforts to hold PG&E accountable, fighting for fair and justifiable rates for San Joaquin County ratepayers. Thus, I am pleased to share that on January 1, 2026, residential electric rates were scheduled to decrease about 5% for customers who get both electricity supply and delivery service from PG&E, compared to 2025 rates.

Additionally, PG&E is providing more bill relief in 2026 to help customers pay overdue energy bills through its [Relief for Energy Assistance through Community Help \(REACH\)](#) and [Match My Payment](#) programs.
