In February, the Board approved a plan that Supervisor Tom Patti and I helped develop with our Probation Chief for a new approach to the issue of homelessness in our community. While the new program, known as SJ CARES, won't be a silver bullet to solve this problem, we know that by having accountability and continuity of care, we can impact lives for the better and improve outcomes in our community. Supervisor Patti and I also both participated in the Animal Protection League dance competition at their annual fundraiser. The Board donated a total of \$50,000 in district funds to help support the new mobile spay and neuter van to ensure that all residents have access to free or low-cost spay and neuter services for their pets. My "Car Wash" dance was a hit, as was Supervisor Patti's reflection back on his disco days. I am proud to serve the people of San Joaquin County with my colleagues on this Board, and I look forward to continued success this year.

SJ CARES - Coordinating Care

The San Joaquin County Board of Supervisors approved the creation of a Community Assessment, Response and Engagement (CARE) team and program to be headed by the County's probation department in response to the on-going crisis of homelessness in our community. Supervisors Paul Canepa and Tom Patti encouraged the Board to adopt the measure, since both have served as representatives on the Ad Hoc Committee on Homelessness. The SJ CARE Team and program will be modeled on a similar approach in Stanislaus County.

"I appreciate the input of Supervisors Canepa and Patti," commented Board Chairman Miguel Villapudua. "As elected officials, they have responded to the homelessness crisis by educating themselves and looking for concrete approaches that our Board can adopt to help the men and women in our community who need help. SJ CARES will allow us to engage already existing resources in innovative ways to try and assist the most vulnerable in our community."

"Our approach to this point has not been as successful as we want. By embracing the success of other agencies and counties, the Board is committed to doing all we can to improve that situation and most importantly, the outcomes for our residents," commented Vice Chair Paul Canepa, who also represents the Second Supervisorial District. "Individual approaches and silos of information haven't served us well. I support this collaborative effort which has everyone working together to expand our impact and be the best stewards of our resources."



SJ CARES - Changing Lives

Supervisor Tom Patti, Third Supervisorial District representative continued, "we have reached out and partnered with our cities, County agencies, and local non-profit groups to look for an innovative, umbrella approach to this continued crisis. We appreciate the Probation Department answering the call for a structured program throughout the County, including outreach, enforcement, care, and coordination for the unsheltered homeless in our community. Their input and willingness to take on new and expanded roles will impact lives and our communities for the better."



The SJ CARES Team aims to quickly connect clients in San Joaquin County with support services. Case managers facilitate access to services, track clients through the process, and ensure continuity of care.



Board Opposes AT&T Action at CPUC

The Board of Supervisors voted to oppose the recent application by AT&T to end it responsibilities as the "Carrier of Last Resort" and encourages County residents to contact the California Public Utilities Commission to make their voice heard on this issue.

San Joaquin County encompasses an area of 1,426 square miles, much of it rural, with seven, potentially eight, cities. Cell service in our county can be spotty with dead zones, areas that don't receive cell signals, either because it's too far from the nearest cell tower, or because it's being blocked by a building or something else in the environment. It is reasonable to expect that we have residents that rely on their landlines whether it be seniors, those with disabilities, or rural occupations, not only for daily routine use, but as a last resort in emergency situations.

Community Clean-Up Events

The Board of Supervisors is proud to partner with the Community Development Department (CDD) to offer community clean-up events, also known as "Dumpster Days." Event times have been updated to 9:00 am to 1:00 pm, based on vendor availability.

These events allow County residents the opportunity to dispose of unwanted household waste in their local area at no-cost. In the first three events, we have collected more than 159,000 lbs. of trash, 584 tires, and provided 240 dump passes to local residents.

Remember, this is also an opportunity to get rid of e-waste like computers, monitors, televisions and old phones. We have collected more than 5,900 lbs. of e-waste at our first three events.
