Resolution Adopting Final County Budget for 2022-2023 Fiscal Year

WHEREAS, the Board of Supervisors of the County of San Joaquin, State of California, set June 22, 2022 at 9:00 a.m. as the date and time for a Public Hearing on the Budget for San Joaquin County for the Fiscal Year 2022-2023; and,

WHEREAS, the hearing was continued from day to day until June 23, 2022; and,

WHEREAS, on June 7, 2022, this Board approved the Proposed Budget of San Joaquin County in the amount of \$2,169,165,884 including Enterprise Funds; and,

WHEREAS, this Board has now fully considered the Budget for the Fiscal Year 2022-2023 and approved various changes therein; and,

WHEREAS, it appears that the appropriations for each cost center in the Proposed Budget of the County of San Joaquin for the Fiscal Year 2022-2023 as heretofore prepared, except for these various changes: the increase in funding of \$328,036 for Aging and Community Services, \$500,000 to support fire response in unprotected areas, offset by a decrease in the Contingency Provision budget, and \$6,500,000 for Public Improvement, for a total adjusted budget of \$2,175,993,920, should be adopted as the Final Budget of the County for said fiscal year; and,

WHEREAS, this Board directs the County Administrator to bring back proposals in the current fiscal year to include Fire Districts in the Proposition 172 allocation, both in the base allocation and/or as a percentage of revenue growth; and,

WHEREAS, this Board directs the County Administrator to work with departments to create a fund to incentivize citizens to install video cameras on their property to assist with illegal dumping efforts, funded by American Rescue Plan Act funds; and,

WHEREAS, this Board directs the County Administrator to work with departments to create a pilot program for diversion programs; and,

WHEREAS, this Board directs Behavioral Health Services to return to the Board within 60 days with a plan for messaging in the local community regarding the dangers of Fentanyl; and,

WHEREAS, this Board directs the County Administrator to bring back a comprehensive proposal including planning and funding for improvements to community centers and veterans halls within 60 days; and,

WHEREAS, the appropriation by object for each budget unit, excluding Special Districts under the control of the Board of Supervisors, is specified in the Final Budget document as required by Section 29089 of the Government Code; and,

WHEREAS, the Board directs that fiscal control be maintained by sub-object and authorizes the County Administrator to exercise administrative controls as they deem necessary and to approve transfers and revisions of appropriations within a budget unit that do not increase the overall appropriations pursuant to their designation under Section 29125 of the Government Code;

NOW, THEREFORE, BE IT RESOLVED that the Final Budget for the County of San Joaquin for the Fiscal Year 2022-2023 is hereby adopted in the total amount of \$2,175,993,920 and that the items required under Section 29089 of the Government Code are contained in the Final Budget Document, summarized below by fund, function, and object:
