

I, the undersigned, say, on information and belief, that in the  
County of SAN JOAQUIN, State of California:

**COUNT 1: RAPE: FORCE/FEAR/ETC PC.261(A) (2)**

On or about March 3, 2019, in the County of San Joaquin, California,  
EMILIANO CANADA CANADA-VARGAS, did commit the crime of FORCIBLE  
RAPE, in violation of Section 261(a) (2) of the Penal Code, a FELONY,  
who at the time and place last aforesaid, did willfully and

1 unlawfully have and accomplish an act of sexual intercourse with a  
2 person, to-wit: "JANE C.H. DOE", DATE OF BIRTH: 02/02/1958, not  
3 his/her spouse, against said person's will, by means of force,  
4 violence, duress, menace and fear of immediate and unlawfully bodily  
5 injury on said person and another. It is further alleged that the  
6 above offense is a serious felony within the meaning of Penal Code  
7 section 1192.7(c) (3).


8 On or about January 2020, in the County of San Joaquin, California,
