

SUBJECT: Report on Exclusive Emergency Ambulance Provider Contract Compliance

The EMS Agency Report on the Exclusive Emergency Ambulance Provider Contract Compliance for AMR for the months of May and June, 2009, represents the nineteenth opportunity to report on AMR's performance under the five year contract. The County's contract with AMR establishes accountability for meeting specific standards and provides the EMS Agency with complete access to data and information on AMR's operational, clinical, and administrative performance.



AMR's May and June 2009, response time compliance for all ambulance zones met or exceeded the 90 percentile standard set by the County with 92.67% for May and 94.46% for June.

Notably, in June 2009, AMR achieved 100% compliance in all 11 ambulance compliance sub-zones for the first time during the

contract period.

The frequent occurrence of delays in the transfer of care by hospital emergency departments continues to impact the availability of ambulances in the EMS system. The EMS Agency is currently soliciting public comments on EMS Policy No. 4980 Receiving Hospital Diversion. This policy is in part designed prevent ambulances from becoming trapped at hospital emergency departments (due to the unavailability of patient beds in the hospital E.D.) which can result in an unacceptable delay in ambulances returning to service.

The EMS Agency is continuing to monitor and assist AMR in analyzing the performance data for improvement opportunities. The complete compliance report for May and June 2009 may be viewed or downloaded from the EMS Agency's website: www.sigov.org/ems.


