

SUBJECT: Report on Exclusive Emergency Ambulance Provider Contract Compliance

The EMS Agency Report on the Exclusive Emergency Ambulance Provider Contract Compliance for AMR for the months of November and December, 2013, provides an in depth review of AMR's performance. The County's contract with AMR establishes accountability for meeting specific standards and provides the EMS Agency with complete access to data and information on AMR's operational, clinical, and administrative performance.



AMR's November and December 2013, combined response time compliance for all ambulance zones met or exceeded the 90 percentile standard set by the County with 92.37% for November and 93.22% for December.

AMR's latest compliance report continues the third year of the second five-year

contract period. Compliance continues at combined response performance levels typical of recent years. AMR exceeded compliance standards in nine (9) of the eleven subzones in November and nine (9) of the eleven subzones in December.





It was a great training opportunity, but also brought forth some 'lessons learned', that are now leading to new training programs based on MCI / Radio Reports. AMR San Joaquin is working on a joint venture with one of our local fire departments to set up a series of 'CPR Saturdays'. This started with a phone call from Waterloo Morada Fire, but can be seen rolled out to most other agencies during 2014. The first of this series is being hosted at Waterloo Morada Fire Station 1, on January 4, 2014, from 0900- 1200. This is open to all public and interested parties.	Had a member of AMR San Joaquin attend the monthly CAHF meeting, which is a group of mostly administrators for short/long term care facilities. Good networking opportunity as well as getting information back and forth between facilities and AMR as a transportation and emergency responder. Met with Captain Todd Luke with the Lodi Fire Department a few times. Starting Early December 2014, AMR will be providing joint training courses to Lodi Fire, covering topics such as the Trauma Triage, Trauma Destination, and related policies to recent updates.
Working with local Public Health, we able to get our healthcare staff completed with their seasonal flu shots, or signed declination forms. We also were able to reach out and help out some local allied agencies by getting them attend our open clinics, promoting interagency relationships.	Went to the monthly 'Stroke Awareness Luncheon' sponsored by 'Healings in Motion'. It was announced this month that our proposal looked good, and we are going to be doing some informational CE courses on this topic to discuss possibilities, requirements, state regulations, hospital status, etc. This is a very proactive program, and we are proud to be a part of this.
