

The EMS Agency Report on the Exclusive Emergency Ambulance Provider Contract Compliance for Escalon Community Ambulance (ECA) for the months of May and June 2018, provides an in-depth review of ECA's performance. The County's contract with ECA establishes accountability for meeting specific standards and provides the EMS Agency with complete access to data and information on ECA's operational, clinical, and administrative performance.



ECA's response time compliance did exceed the 90th percentile standard set by the County for May with 96.67%. April's compliance did not meet the 90th percentile standard with 89.47%. The combined twomonth percentile with 117 responses
