- SUBJECT: STEMI System of Care Update

Medical treatment of both San Joaquin County (SJC) citizens and visitors for acute heart attacks (STEMI) continue to be lifesaving and administered with a high level of expertise.

SJCEMSA engages regularly with STEMI Receiving Centers (SRC) regarding opportunities to improve the STEMI System of Care in San Joaquin County. As a result, a project that focuses on expediting the time from identification of a STEMI patient at an acute care hospital (non-SRC) to transfer of patient to a SRC is ongoing. As this project nears completion the SJCEMSA STEMI System of Care can expect to see a streamlined process related to STEMI patient transfers, resulting in a decrease burden of hospital resources and quicker first medical contact to reperfusion times.

In addition, SJCEMSA continues to use a standardized data collection and reporting processes consistent with other American Heart Association's Get with the Guidelines CAD Centers and System of Care participants.

- SUBJECT: Stroke System of Care Update

Medical treatment of both San Joaquin County citizens and visitors for stroke related illnesses continue to be administered at a high level of expertise. All seven acute care hospitals in San Joaquin County have successfully completed the designation renewal process for the agreed period of October 2023, through October 2027.

All Primary Stroke Centers (PSC) in SJC transitioned to an intravenous thrombolytic medication named Tenecteplase. Use of Tenecteplase decreases the time from thrombolytic therapy to arrival of patient at a Comprehensive Stroke Center for treatment of Large Vessel Occlusions.

In addition, SJCEMSA continues to use a standardized data collection and reporting processes consistent with other American Heart Association's Get with the Guidelines Stroke Centers and System of Care participants.

SUBJECT:	San Joaquin County Trauma Program

San Joaquin General Hospital (SJGH) continues to be San Joaquin County's only designated Trauma Center. SJGH and San Joaquin County Emeregeny Medical Services (SJCEMSA) continue to prepare for the upcoming American College of Surgeons Committee on Trauma (ACS-COT) Level II survey scheduled for August of 2024.

SJGH activates trauma services on an average of 3758 patients a year with majority of trauma patients transported by EMS and meeting EMS Policy No. 5210, <u>Major Trauma</u> <u>Triage Criteria</u>.

The chart below represents the mechanisms of injury for quarter one, two, and three of 2023.
