SUBJ.: Availability of Coronavirus (COVID-19) Therapeutics v.4

The purpose of this memorandum is to provide you current information on the availability of COVID-19 therapeutic products in San Joaquin County.

Oral Antiviral Medications:

The Food and Drug Administration (FDA) has issued emergency use authorization (EUA) for Paxlovid¹ and Molnupiravir² for out of hospital treatment of patients with COVID-19. These medications require a physician prescription for patient self-administration orally at home.

Paxlovid and Molnupiravir are currently available by prescription throughout San Joaquin County at the following Federal Retail Pharmacies and Kaiser Permanente Pharmacies:

Monoclonal Antibodies Therapeutics:

Monoclonal antibodies (MAB) that target the SARS-CoV-2 spike protein have been shown to provide clinical benefit in treating infected adults and pediatric (12 years of age and older

weighing at least 40 kg) outpatients with mild to moderate symptoms, who are at risk for disease progression or for pre-exposure prevention.

The EUA approved anti-SARS-CoV-2 MAB recommended for Omicron, which is the predominate variant in California, is Sotrovimab³. This product is physician prescribed, administered intravenously, and used for outpatient populations with mild to moderate symptoms and or who are at risk for disease progression.

The following clinics and hospitals are administering Sotrovimab:

- Kaiser Hospital Manteca;
- Kaiser Stockton Clinic;
- San Joaquin County Clinics;
- San Joaquin General Hospital;
- St. Joseph's Medical Center;
- Sutter Tracy Community Hospital.

The EUA approved anti-SARS-CoV-2 MAB recommended for pre-exposure prevention is Evusheld⁴. This product is physician prescribed and administered through intramuscular injections.

- Kaiser Stockton Clinics.
