As a property owner, tenant or person with vested interest in the project vicinity, please be advised that the County of San Joaquin, Solid Waste Local Enforcement Agency (LEA), has accepted an application to revise an existing Solid Waste Facility permit (SWFP) from San Joaquin County Public Works for North County Sanitary Landfill and Recycling Center located at 17720 E Harney Lane, Lodi, CA. The LEA, certified by the Department of Resources Recycling and Recovery (CalRecycle), enforces state laws and regulations at solid waste sites within the County of San Joaquin, including all disposal facilities.

Purpose of the Meeting:

The LEA provides public notice and conducts an informational meeting after accepting an application to revise an existing SWFP as complete and correct, pursuant to Title 27, California Code of Regulations (T27 CCR) § 21650. The SWFP application was received on **July 14, 2025**, and accepted as complete and correct on **July 18, 2025**. The Public Notification and Meeting will be conducted within 60 days of application receipt pursuant to T27 CCR §§ 21660.2 - 21660.3.

Description of Project:

The North County Sanitary Landfill and Recycling Center currently accepts a maximum amount of 1,200 tons of solid waste per day and a traffic volume of 850 vehicles per day. Current times for accepting solid waste are 7 am – 5 pm, seven days a week. Current times for Ancillary Operations/Facility Operating hours are 6:30 am – 7 pm, seven days a week.

To improve financial efficiency, the County plans to consolidate waste disposal services. Therefore, the County is proposing the limits be increased to a maximum of 4,000 tons and 1,200 vehicles per day. The County is also proposing to accept solid waste one hour earlier, 6 am – 5 pm, and conduct ancillary operations from 5:30 am – 7 pm, seven days a week.

Findings:

The LEA has determined that:

- The requested changes will require a revision of the existing SWFP.
- The application meets the filing requirements for a revised permit pursuant to T27 CCR § 21570.
- The application was accepted as complete and correct on **July 18, 2025**.

Options for Submitting Written Comments:

The San Joaquin County LEA will accept written comments on this permit action up to 10 business days after the informational meeting. Please address all correspondences to:
