Please be advised that the San Joaquin County Environmental Health Department (EHD) received and approved a Joint Technical Document (JTD) amendment to the Solid Waste Facility Permit for the Foothill Sanitary Landfill. The EHD is the Solid Waste Local Enforcement Agency (LEA) for this facility. The LEA is certified by the California Department of Resources Recycling and Recovery (CalRecycle) to enforce state laws and regulations at solid waste sites in San Joaquin County.



<u>Description of Project and LEA's Determination</u>

Foothill Sanitary Landfill is a 674-acre existing solid waste facility located at 6484 N Waverly Road in unincorporated San Joaquin County. On December 4, 2025, the LEA received an application package amending the Joint Technical Document (JTD).

The amendment changes the facility operator from Foothill Sanitary Landfill Inc. to San Joaquin County Public Works, Solid Waste Division. The amendment updates the employee descriptions, qualifications and training. The amendment adds a Worksite Emergency Plan.

The LEA finds that the proposed changes are consistent with all applicable certified and/or adopted CEQA documents, is consistent with State Minimum Standards, and does not conflict with the terms and conditions in the current solid waste facilities permit. The LEA approved the amendment on **December 11, 2025.**
