On behalf of the EEO Program, we would like to congratulate the following mentors and mentees for their participation and successful completion of the 2009 Mentor Partnership Program.

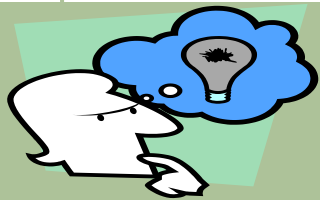
