 - Cost/Schedule
 - Alignment with County Strategic Priorities
 - Benefits (Who/How/When)

- Draft Project Request Scoring by ISD PMO
- Project Request Scoring and Prioritization by ITESC
- Project Funding Recommendations by ITESC
