1. Review of previous identified action items (none)
2. EOC Activations - OES continues to be activated in support of both COVID-19 Pandemic and the Drought per the County's Emergency Operations Plan. March will mark two full years of COVID-19 activation. OES also continues to gather intelligence through the Agricultural Drought Task Force and disseminate that intelligence through the monthly Situation Report for the 2021 Drought Incident. In addition, OES continues working with non-profit agencies to seek out a partner to work on developing our own Bottled Water Program, before a need there is a need

### 3. OES Grant activities

#### a. DWR 2

- i. Fiscal Update – Irene Judd informed attendees that the some checks for DWR 1 and Statewide final retention were sent out, along with some of the DWR2 container reimbursements.
- ii. PED Maps – Contract is in progress.
- iii. Just in Time Training – Contract is being finalized
- iv. Logistics Base – Working with County Parks on the location, tentatively, pending MOU at Oak Grove Regional Park.
- v. Flood Containers and MOU – OES is working on an MOU for the County containers to be redistributed.

#### b. PSPS Resilience Grant

- i. PSPS 2019: There are still 2 projects remaining uncompleted of the seven allocated. This grant ends October 2022. City of Stockton and Montezuma Fire are on track for meeting all requirements. All funding has been allocated.
- ii. PSPS 2020: There are 8 total projects, four are completed. Those are Waterloo-Morada Fire, SJC Public Works, City of Lathrop, Ripon Unified School District, and City of Ripon Public Works. All funding has been allocated. An offer by CalOES to extend the project deadline from March 2022 to December 2022 was accepted and should be formalize by the end of February. After the formal notification is received all parties will be provided the new information and status checks will be requested.

- c. DWR Round 3 – Applications due by end of March. Stakeholder planning meeting scheduled for Feb 9, at 2:00 pm (will be held via TEAMS). Contact OES for meeting invite.

### 4. Emergency Operations Plan revision

- a. EOP Update was formally adopted by the Board of Supervisors on January 25, 2022. Once all signatures have been gathered, the final version will be shared far and wide (by end of February). The EOP can be found on the OES Website at: <https://www.sjgov.org/departments/oes/plans>. In addition, all annexes will be up for review over the coming year.

## 5. Activities

- a. Multi-Jurisdictional Local Hazard Mitigation Plan – The NOI was completed and submitted on January 21, 2022. The subapplication is in progress. The plan is to ultimately put out a formal RFQ for a vendor to do the work of the plan, pending acceptance of the grant funds. It will be very important for all stakeholders to be involved in the process. Letters of Commitment for the Multi-Jurisdictional plan are still being accepted. We need them from any special district, city or agency/department that may plan to adopt the plan as their own for federal or State future funding for mitigation project.

## **SEMS Executive Management Course G-402**

SEMS/NIMS compliance is required for reimbursement of funds expended during an incident response.

- Introduction to the National Incident Management System (NIMS)
- ICS 402 - ICS Overview for Executives/Senior Officials
