

What is Illegal Dumping?

You MAY NOT dispose of any trash in dumpsters or containers not owned by you, nor along roadways, waterways, fields, wooded areas, parks, or any other unacceptable locations. Pouring chemicals, pesticides, used automotive fluids, and other pollutants into storm drains, waterways, and on the ground is also illegal. It's also unlawful to burn trash, bury trash, or drop it at any location other than a legal acceptance facility.

Illegal Dumping: A Serious Problem

A record-setting amount of garbage, graffiti and illegal dumping is polluting our region. If not cleaned up and prevented, it could threaten our health, safety, environment and most important, our citizens, for generations to come.

Illegal dumping accounts for 2,600 tons of trash in San Joaquin County communities each year, and costs nearly \$1.3 million annually to clean up littered areas.

What's at Stake?

- Neighborhoods suffer not only from hazardous trash, but it can also cause public health and safety issues, a decline in property values, and loss of community pride.
- Businesses suffer due to extra clean-up costs and decreased customers due to unsightly garbage.
- Farmers suffer because fields, crops and property are destroyed.
- Our environment suffers from pollutants being released into streams, woodlands, and wetlands, harming people and wildlife.



Report Illegal Dumping

You can help **STOP** illegal dumping. If you see someone dumping, contact law enforcement at 209-468-4400.

If you see an illegal dump site, report it using the My San Joaquin App or call 209-468-3074.

Illegal dumping is a serious offense and may result in criminal prosecution. Each case of illegal dumping is investigated and violators may be subject to a fine of up to \$10,000 and possible criminal prosecution.

Try to report the following:

• Exact location of the dumping



- Date and time of incident
- Vehicle description and license plate number
- Take a photo or video if possible



County Hazardous Waste Disposal

San Joaquin County Public Works Department offers multiple ways to dispose of garbage so it doesn't end up littered in our communities.

- Household Hazardous Waste Facility (HHW) provides a FREE service to residents to properly dispose of hazardous materials such as paint, oil, chemicals, batteries, and pesticides. HHW satellite collection events are also held annually throughout the county.
- County businesses and organizations that generate less than 220 lbs. of hazardous waste monthly may qualify for a Small Business Program to get lower rates for disposal of hazardous materials.
- County residents can dispose of the following items for FREE at convenient County-owned solid waste facility locations:
- Mattresses
- Tires
- Appliances/Electronics
- Refrigerators
- Used Oil
- Sharps and Medications

Other Ways to Recycle

- Donate gently used home goods, such as clothing, furniture, electronics, or appliances to any Goodwill, Salvation Army, or other thrift store.
- For items that won't fit in your waste bin, contact your residential waste collector to find out if a clean sweep event or bulky item pick-up is available.
- Post unwanted items on freecycle.org, craigslist.org, or similar websites.
- · Get rid of unwanted vehicles by donating to charity or selling to an auto parts yard.
- Dispose of trash properly by taking it to any public waste disposal facility.
