**Country Club Boulevard Underground Utility District:  
Gathering your feedback**

In accordance with the California Public Utilities Commission (CPUC) Rule 20A Undergrounding Program, the San Joaquin County Department of Public Works (County), in cooperation with PG&E, proposes to establish an Underground Utility District (UUD) along Country Club Boulevard. The proposed UUD limit is between Pershing Avenue and Franklin Boulevard as shown on the map below.



**Why Underground Existing Utilities?**

Undergrounding overhead utilities will decrease the heavy concentration of overhead electrical facilities, improving safety, service reliability, and aesthetics in this area.

**Formation of an Underground Utility District**

Properties receiving overhead services within the UUD limit will require service panel conversion work to connect to the underground system. The conversion costs are funded by the CPUC Rule 20A Undergrounding Program. Subject to approval by the Board of Supervisors, a public meeting will occur in early 2021. The exact date and time will be set and posted according to established procedure for County public hearings, including a mailed notice to affected property owners and interested parties. **We Need Your Input**

If a UUD resolution is passed, property owners and residents within the UUD will be notified in advance of the construction schedule. Currently, we estimate that utility company will take 4-7 years to complete the project. Affected residents, property owners, business owners, and other people interested in the proposed UUD are urged to **provide feedback by Friday, January 15, 2021**, regarding the proposed UUD using the enclosed, pre-addressed envelope.
