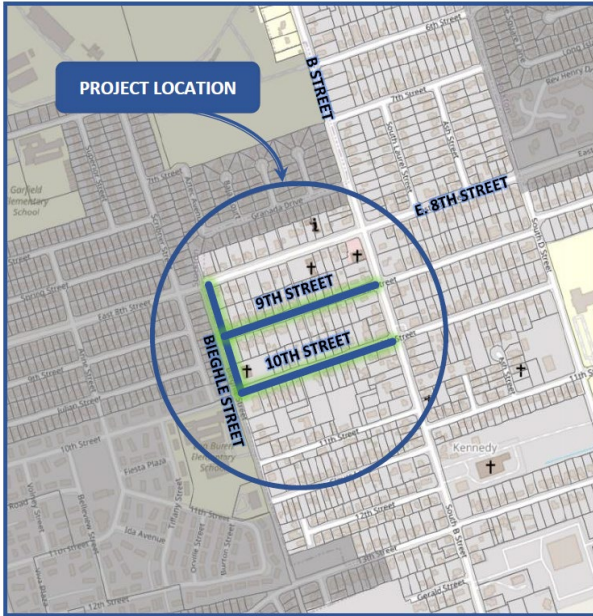

Public Works is pleased to announce the next phase of infrastructure improvements in your area, the **South Stockton Sidewalks-Phase 3 Project!** This project will improve safety and roadway drainage by constructing:

- ✓ Pedestrian sidewalks that provide safer routes to school and neighborhood points of interest.
- ✓ A storm drain system to capture roadway runoff.

# FREQUENTLY ASKED QUESTIONS

## SOUTH STOCKTON SIDEWALKS – PHASE 3

BIEGHLE STREET: EIGHTH STREET TO TENTH STREET

NINTH STREET: BIEGHLE STREET TO B STREET

TENTH STREET: BIEGHLE STREET TO B STREET

### 1. What is the purpose of this project?

The South Stockton Sidewalks – Phase 3 project will improve safety and roadway drainage by constructing:

- Sidewalks, providing safer routes to schools and local points of interest.
- A storm drainage system to capture roadway runoff.

### 2. What is the duration of the project and will there be any night work?

Construction is tentatively scheduled to begin in August 2021 and be completed by mid-October 2021. Construction activities will be performed Monday through Friday, from 7 am to 7 pm, with occasional work on the weekend. Night work is not planned; however, residents will be notified in advance of any scheduled night work.

### 3. When will the pre-construction public meeting be held?

The meeting will be held approximately 1 to 2 weeks in advance of the construction start date. A follow-up notification letter with additional details will be provided to you prior to the meeting, which will be held in accordance with COVID-19 restrictions.

### 4. Will I continue to have access to and from my home or business during construction?

Yes, residents (and visitors) within the project limits will be provided access at all times. Access to driveways will be maintained with minimal interruption.

Through traffic will be detoured around the project limits. Detour signage will be posted prior to the start of construction.

### 5. Will trash pickup and delivery of goods and services continue during construction?

Yes, the hired contractor will coordinate with service providers to ensure services remain uninterrupted.

**6. Will utility services continue to be provided during construction?**

Yes, utility services will continue to be provided during construction with minimal interruption. Residents will be notified in advance of any scheduled work that may affect utility services.

**7. Who do I contact if I have questions during construction or after business hours?**

Prior to the start of construction, contact information of construction project managers/personnel will be provided to residents.

**8. What are the general impacts to property frontages?**

Some facilities within the limits of work may require removal, reconstruction, and/or relocation. Existing driveway entrances will be reconstructed. Sprinklers will be relocated as needed. Property owners/residents will be notified by mail of any other frontage specific impacts.

**9. Will you mitigate for noise?**

Residents should anticipate typical noise associated with construction activities; however, the project will detour through traffic around the construction site and implement anti-idling measures.

**10. Will dust be mitigated during construction?**

Yes, the contractor will have measures in place to control dust production during construction.

**11. What is the source of project funding?**

Community Development Block Grant (CDBG).

**12. Will there be any future phases of the South Stockton Sidewalks?**

Yes, contingent upon funding availability. The next phase (Phase 4) is tentatively scheduled to occur in the summer of 2023 and will consist of constructing sidewalks and a new storm drainage system along:

- Clover Lane (Bieghle Street to B Street)
- Twelfth Street (Bieghle Street to B Street)
- Bieghle Street (South End to North End)
