- <u>Question #1</u>: Can Primavera 6 be used for the scheduling software in lieu of Microsoft Project? **Answer #1**: Yes, Primavera 6 can be used in lieu of Microsoft Project.
- Question #2: Are you looking for the CM team to create a construction CPM schedule with trade activities and CM oversight to show the constructability of the project so it can be used during the project or are just looking for a high level schedule just for the CM team to manage the project?
- Answer #2: For this particular project, a high level schedule (for the CM to manage the project) is acceptable. The schedule is to be prepared using the information currently available and reasonable assumptions made to address any gaps or missing details in the work scope
- Question #3: Will the two projects be bid as separate contracts or as one?
- **Answer #3:** The work will be administered as one contract encompassing two distinct bids schedules. Project locations shall be tracked individually, and some overlap in the construction timelines should be expected.
- Question #4: Are there engineers' estimates available for these projects
- Answer #4: An Engineer's Estimate is not available; however, the Phase 1A bid tab can be viewed on Bid Express as a reference. Project documents and bid tabs on Bid Express are accessible free of charge.
- Question #5: Section 1 10 appear to be missing from the specifications, including the bid item list, Can these sections be provided?
- Answer #5: The front ends for Lincoln Village were provided and can be used for reference.

 The project will be bid together so there will only be one set of specifications provided. The project specifications for Phase 1A are available on Bid Express and can be used as reference.
- Question #6: Section 77S-9 of the special provisions refers to Appendix B-4 for the Water service Summary Table but the appendix appears to be missing, will appendix B-4 be provided?
- Answer #6: Appendix B-4 is not yet available. Once completed, it will include the total number of 1-inch in-tract water service connections, separated by installation method (open trench versus directional drilling). These quantities are summarized in the estimated quantities provided (attached).
