

Compliance Guide

The C&D Recycling Program is for Applicable Projects located within San Joaquin County ONLY. NO out of County C&D materials accepted.

Protect Yourself!

If your signature is on the permit application, you are responsible for C&D compliance!

- Frequently, unlicensed persons performing "handyman" services will have a property owner obtain a permit for work being performed on the owner's behalf. If you are working with a contractor, have the contractor apply for permits. This shifts the responsibility for C&D compliance to the contractor.
- Ensure that all contractors providing services are fully licensed with the State of California and are insured.

Compliance Tips

- **Recyclable materials** that have been separated into single stream loads (e.g. metal, wood) can be taken to any vendor where Solid Waste Personnel can verify the materials are recycled.
- Mixed debris and waste MUST be delivered to designated County facilities.
- If you contract for bin service: Advise the bin service provider of C&D requirements, provide them with your Building Permit # and inform them that mixed debris loads MUST be delivered to a County facility.
- If you haul mixed debris yourself: Deliver to designated County facility, declare the load as C&D material, and <u>provide the Building</u> <u>Permit # to the facility attendant.</u>
- **Save all receipts** for recycling, disposal, and/or donation activities.
- Submit receipts and Diversion Report within 30 days of the projects final inspection to San Joaquin County's Solid Waste Division or email to: PWCDServices@sjgov.org.


San Joaquin County Construction & Demolition (C&D) Ordinance

In 2009, the County Ordinance #4370 also known as the Construction, Demolition, and Landscaping Debris Recycling and Diversion Ordinance was adopted. The goal of this Ordinance was to implement a source reduction and recycling program to reduce, reuse and recycle; helping to divert a minimum of 65 percent of construction waste as defined and set forth by current CalGreen standards. Definitions of Construction and Demolition Debris, Inerts, and Organics are listed below. **All C&D debris that is unable to be recycled or reused** *MUST* be delivered to a facility designated by San Joaquin County's Director of Public Works.

Recyclable Debris

To Comply with San Joaquin County's C&D Ordinance you must recycle:

Separating debris increases the amount of material that is pulled from mixed loads and recycled. Percentages below reflect the typical amount of debris recovered from mixed loads.

C&D Reporting

Persons applying for a Construction, demolition, and/or renovation permit that is deemed as an "Applicable Project" under San Joaquin County's C&D Ordinance must:

- 1) Fill out a Diversion Plan prior to undertaking an Applicable Project.
- 2) Turn in a Diversion Report within thirty-days of project completion, along with receipts and/or other documentation showing the material description, weight, and contact information for the facility(ies) where material(s) were recycled.

Documents must be submitted to San Joaquin County's Solid Waste Division.

Recycling & Debris Management Ways to Comply with the C&D Ordinance:

- Take mixed debris to a County-designated facility, declare the load as C&D, and provide building permit # to facility attendant.
- Save receipts documenting debris was delivered to approved facility.
- Submit receipts and Diversion Report to the SJC Solid Waste Division or email to: PWCDServices@sjgov.org.
- This will constitute full compliance with the Construction & Demolition Ordinance.



- Separate debris into single stream materials such as metals, wood, inerts or organics.
- Deliver separated materials to any verifiable recycling or reuse facility.
- Take remaining debris to a County-designated facility.
- Save all receipts and documentation showing the weight of the load, the materials delivered, facility location, and contact information.
