ACCEPTABLE WASTE

Commercial and household waste; construction/demolition waste; agricultural waste; large dead animals; white goods such as refrigerators, freezers, and A/C units; tires; small pickup loads of soil or gravel; used cooking oil from homeowners only (no commercial); large bulky items/hard-to-handle materials. Oil filters (Limit 12).

UNACCEPTABLE WASTE

Septic tank waste; toxic materials; drums larger than 5 gallons; infectious waste; liquid waste; cannery waste; hazardous waste; ammonia refrigerant units; large loads of soil or gravel; burned wastes.

RATES

Customers with UNCOVERED/UNSECURED LOADS must pay a double disposal fee or purchase a tarp.





SPECIAL HANDLING FEES:

Large Bulky Items/Hard-to-Handle	\$123.97 per ton. (Minimum charge at \$32.50)
Items including but not limited to: RV trailers, mobile homes (remove thermostats and appliances, dismantle the camper trailer into small sections, and bring a Junk Slip from DMV), camper shells; cab-over campers (remove all thermostats and appliances), boats, large concrete, wire, tree stumps, large/long pipes, drip hoses, large wooden/metal beams, pressure treated wood, and creosote coated wood.	

Dead Animals	\$135.25 per ton. (Minimum charge at \$32.50)
Environmental Health Permit/Waiver may be required (Call 209-468-3420), must call site in advance.
