CALIFORNIA LAW: SINGLE-FAMILY RESIDENCES MUST RECYCLE!

State of California Mandates Require Single-Family Residences to Recycle Organics and Other Recyclable Materials.
RECYCLING AND COMPLIANCE IS AS EASY AS 1-2-3.

CONTAINER/BIN	TYPE OF MATERIALS:
1. ORGANICS 	Organic Materials May Include: <ul style="list-style-type: none"> • Green Waste • Food Waste • Food Soiled Papers • Wood Waste (non-hazardous) • Landscape & Pruning Waste
2. RECYCLABLES 	Recyclable Materials May Include: <ul style="list-style-type: none"> • Paper • Plastic • Glass • Metals • Cardboard • Bottles & Cans <p><i>Recyclable materials vary based on collector and current recycling markets. Check with your local collector for materials that can be placed in your recycling container.</i></p>
3. WASTE 	Materials that... <ul style="list-style-type: none"> • Do not belong in the organics or recyclable categories above • Are non-hazardous • Are not banned from the landfill <p>...may be placed in the waste container.</p>

PUT YOUR ORGANICS CART OUT EVERY WEEK - EVEN IF IT'S NOT FULL

Landfills Are the Third Largest Source of Methane Gas in California. Organic waste in landfills emits:

- 20% of the state's methane, a climate super pollutant 84 times more potent than carbon dioxide.
- Air pollutants which contributes to health conditions like asthma.

Organics like food scraps, yard trimmings, paper, and cardboard make up half of what Californians dump in landfills.

Reducing Short-Lived Climate Super Pollutants like organic waste will have the fastest impact on the climate crisis.
