

OFFICES UP FOR ELECTION GUBERNATORIAL GENERAL ELECTION

FEDERAL VOTER-NOMINATED OFFICES – ADVANCED FROM PRIMARY

Every candidate must be at least 25 years of age, a U.S. citizen for seven years, and a resident of California at the time of assuming office if elected. A sworn statement is required to confirm that the candidate meets the statutory documentation requirements when nomination papers are filed. There are no district residency requirements for Members of Congress.

U.S. Constitution, Article I, § 2

The candidates appearing on the general election ballot are those who advanced from the primary election under California's top-two primary system.

Candidates may purchase a Statement of Qualifications for inclusion in the voter information materials. The applicable estimated cost varies by district and is listed below.

STATE VOTER-NOMINATED OFFICES – ADVANCED FROM PRIMARY

Candidates must be U.S. citizens, registered voters, and otherwise qualified to vote for the office at the time nomination papers are issued. Candidates may not have been convicted of a felony involving bribery, embezzlement, extortion, theft of public funds, perjury, or conspiracy to commit any of those offenses. Candidates for the State Legislature must also have been residents of California for at least three years, and residents of the legislative district for at least one year, immediately preceding the election. Legislative offices are subject to California's term limits.

The candidates appearing on the general election ballot are those who may advance from the primary election under California's top-two primary system for the following offices: Governor, Lieutenant Governor, Secretary of State, Controller, Treasurer, Attorney General, Insurance Commissioner, Superintendent of Public Instruction, Board of Equalization – District 1.

Candidates running for state assembly may purchase a Statement of Qualifications for inclusion in the voter information materials. The applicable estimated cost varies by district and is listed below.

JUDICIAL OFFICES

Retention elections for Justices of the California Supreme Court and Courts of Appeal are administered through the California Secretary of State's office. These justices do not appear on the Primary Election ballot. Instead, justices appear on the General Election ballot in a judicial retention election, in which voters decide whether each justice shall be retained in office by voting "Yes" or "No." Retention elections are not contested elections; there are no opposing candidates or write-in candidates.

For Superior Court Judges, if an incumbent's name did not appear on the Primary Election ballot, it must appear on the General Election ballot if a petition for a write-in campaign is filed with the elections official. The petition requirements are the same as for the Primary Election and must be submitted no later than 83 days before the General Election.

COUNTY BOARD OF EDUCATION, SCHOOL DISTRICTS, AND COMMUNITY COLLEGE TRUSTEES

The County Board of Education serves as the governing body for the County Office of Education and is responsible for setting policies, adopting budgets, overseeing the County Superintendent of Schools, and providing support and oversight services to local school districts as required by law. Board members act within their respective trustee areas and exercise authority as prescribed by the Education Code.

Candidates must be registered voters residing within the trustee area they seek to represent and must meet all general eligibility requirements for elective office.

SPECIAL DISTRICTS

They are governed by the Health and Safety Code, Government Code, and other applicable California statutes, which operate independently from cities and counties and are created under state law.

Candidates must be registered voters living within the district or division they seek to represent and must meet all general requirements for holding public office.
