Message From The Registrar of Voters' Office

Preparations for the upcoming November 4, 2025, Statewide Special Election are in full swing at the San Joaquin County Registrar of Voters (ROV) office.

On Monday, September 29, the ROV conducted the state-mandated full Logic & Accuracy (L&A) Test of the county's voting system. The test began at 8:00 a.m. at the ROV Office, located at 44 N. San Joaquin St., Suite 350, Stockton, CA, and continued until completion at the ROV Warehouse.

San Joaquin County residents and media representatives were invited to observe the test, which also included the opportunity to review the final reports and processes used to verify election accuracy.

The L&A Test ensures that every component of the tabulation system is functioning accurately and in accordance with state law.

It examines all precinct ballots for the upcoming election and tests the entire vote tabulation process, including reporting functions.

If any issues are found during the test, they must be corrected, and the process repeated. Once the system accurately counts the test ballots, it is approved for live ballot tabulation.

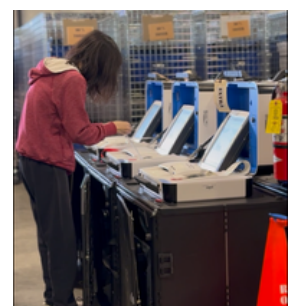

San Joaquin County encourages residents to take an active role in the elections process by observing and participating.

The upcoming November 4, 2025, Statewide Special Election is an opportunity to participate in various stages of the election process. Public transparency is a cornerstone of election integrity, and all residents are welcome to get involved.

There are several key upcoming election processes to be aware of: Vote-by-Mail Ballot Processing, Election Day at Polling Places, Ballot Tabulation, and the Official Canvass.

Vote-by-Mail Ballot Processing begins October 6 at the Registrar of Voters (ROV) Office, located at 44 N. San Joaquin St.

Polling Places can be visited by the public for observation on Election Day Tuesday, November 4. Ballot Tabulation begins after 8:00 p.m. at the ROV Warehouse, on Election Night.

Official Canvass of the Election takes place from November 5 through December 2, 2025, and is also open for public observation.

Any San Joaquin County resident may come and observe the processes. Public participation helps uphold transparency and public confidence in the election process.
