**Notice of 2023-2024 Unsecured Property Tax Due**

Phonxay Keokham, San Joaquin County Treasurer-Tax Collector, has mailed personal property tax bills to 16,617 business, boat, and aircraft owners in San Joaquin County as of July 20, 2023. Owners of personal property in San Joaquin County as of January 1, 2023, must pay the tax. If you do not receive a tax bill by July 28, 2023, please download a tax bill from [sjcttc.org](http://sjcttc.org) or call the Unsecured Section in the San Joaquin County Treasurer-Tax Collector's Office at (209) 468-2133. Failure to receive a tax bill shall not relieve the lien of taxes, nor shall it prevent the imposition of penalties.

Unsecured taxes are due on the date billed. The date of delinquency is Thursday, August 31, 2023. If the tax is not paid by 5:00 p.m., August 31, 2023, a ten percent (10%) penalty will apply. Delinquent unsecured property taxes are subject to additional penalties, fees, and collection enforcement if unpaid after 60 days.

Property taxes may be paid online, by phone, by mail, or in office. Please go to [sjcttc.org](http://sjcttc.org) to pay online or obtain instructions to pay by phone. Payments may be mailed to SJC TTC, P.O Box 2169, Stockton, CA 95201-2169. Mailed payments must be United States Postal Service postmarked by the delinquent date to avoid late penalties. Payments may also be made at the San Joaquin County Treasurer-Tax Collector's Office located at 44 North San Joaquin Street, Suite 150, Stockton, CA, 95202. Our regular business hours are 8:30 a.m. to 4:30 p.m. Monday through Friday, excluding holidays. We will remain open until 5:00 p.m. on Thursday, August 31, 2023.

A convenience fee will be charged by the company supporting these services when paying with a credit card or debit card. The convenience fee is in addition to the property taxes paid. For your convenience, e-check (electronic check) payments are accepted free of charge.
