Sales Closing Date Nears for Crop Insurance Programs

USDA Risk Management Agency (RMA) reminds producers that the final dates to apply for crop insurance are fast approaching. **May 31, 2017**, is the last day to buy or change your policy for Potatoes. Producers need to purchase, review, or modify their crop insurance policies before these sales closing dates have passed. Crop insurance provides protection against crop production losses due to natural perils such as drought, hail, and excessive moisture. Crop insurance is sold and delivered solely through private crop insurance agents. In order to receive premium subsidies, the insured must certify that they meet [Highly Erodible Land Conservation and Wetland Conservation](#) requirements (AD-1026) with Farm Service Agency (FSA). NRCS Application Deadline for 2017 EQIP Funding is Fast Approaching

The application deadline for NRCS' final round of Environmental Quality Incentives Program (EQIP) funding is approaching fast—May 26th, just a month away. NRCS takes applications year round and bundles and ranks them for funding purposes three to five times per year. This is the final bundle planned for fiscal year 2017.

While applications for all conservation purposes are welcome, NRCS is currently working to spread awareness on [air quality opportunities](#) for which there is [considerable funding available](#). EQIP Air Quality funding can help replace older farm equipment engines with newer, cleaner ones. To date, we've helped replace more than 4,000 of these old units. The emissions-reduction benefit is similar to having removed more than 1 million cars off California's roads. This practice is [available in California's 35 counties](#) not in compliance with federal air quality standards.

Additional practices available statewide include: 1) Treat unpaved farm roads to limit dust; 2) Repower irrigation engines with cleaner options; 3) Adopt conservation tillage practices; 4) Combine and limit field passes; 5) Use smart sprayers in orchards; 6) Chip orchard/vineyard

removals; 7) Safely dispose of chemically-treated wooden stakes; and new in 2016-- 8) Use “low-dust” nut harvesters.

Interested farmers are encouraged to contact their local Service Center very soon to start the conservation planning process, and to apply for assistance.

Deadline Approaching for Conservation Compliance

The deadline to have a signed Highly Erodible Land Conservation and Wetland Conservation Certification (AD-1026) on file with FSA is **June 1, 2017**. This requirement applies to all producers seeking federal crop insurance premium subsidies for the 2018 reinsurance year (July 1, 2017 to June 30, 2018.) **Producers who filed an exception certification last year must file a form AD-1026 with FSA by June 1, 2017 to maintain premium subsidies on your policy for 2018.** Producers without a signed AD-1026 on file can still purchase crop insurance, but they will no longer be eligible to receive the government paid premium subsidies. NRCS Invites Proposals for Conservation Innovation Grants

USDA’s Natural Resources Conservation Service (NRCS) in California is now accepting proposals for its Conservation Innovation Grants (CIG) program. Up to \$375,000 is available for one- to three-year grants. The maximum award amount for any project will not exceed \$75,000 in FY 2017. Proposals are due by June 7, 2017. In 2017 NRCS California is prioritizing proposals that improve the “technical toolbox” to address the following on-farm resource concerns: soil and water quality, wildlife habitat, water conservation, forest health, air quality, waste recycling and energy conservation. Funds will be awarded through a statewide competitive grants process and in 2017 will not include a pre-proposal process. Eligible applicants include state and local government, nongovernment organizations, Tribal governments, eligible private business and individuals. Southern California Farmers are Eligible for NRCS Air Quality Assistance

Technical and financial assistance is available through USDA’s Natural Resources Conservation Service (NRCS) to help farmers and ranchers in Southern California to make improvements in their operations that can lead to improved air quality. Assistance is made available through NRCS’s Environmental Quality Incentives Program (EQIP). EQIP applications are accepted year-round, but interested producers need to be ready by May 26, 2017, to be considered for this

year's funding. To be ready for EQIP funding consideration, interested applicants will need to submit the application form and meet program eligibility requirements. NRCS staff will work together by developing a conservation plan, which can lead towards approval of the 'EQIP schedule of operations.'

NRCS can help agricultural producers implement conservation practices that reduce air pollution from agricultural sources, including chipping orchard or vineyard debris, tillage management, repower in-use irrigation pump engines, and implementation of "low-dust" nut harvesters. These examples are available statewide for all qualifying producers. For fiscal year 2017, the approved counties for tractor and replacement in Southern California include: Imperial, Inyo, Kern, Los Angeles, Mono, Orange, Riverside, San Bernardino, San Diego, San Luis Obispo, and Ventura.

USDA Issues Safety-Net Payments to the Farmers in Response to 2015 Market Downturn

The U.S. Department of Agriculture (USDA) announced many of the 1.7 million farms that enrolled in either the Agriculture Risk Coverage (ARC) or Price Loss Coverage (PLC) programs will receive safety-net payments due to market downturns during the 2015 crop year. This fall, USDA will be making more than \$7 billion in payments under the ARC-County and PLC programs to assist participating producers, which will account for over 10 percent of USDA's projected 2016 net farm income.

These payments will help provide reassurance to America's farm families, who are standing strong against low commodity prices compounded by unfavorable growing conditions in many parts of the country. Overall, 76 percent of participating farm base acres are enrolled in ARC-County, 23 percent in PLC and one percent in ARC-Individual. The USDA Natural Resources Conservation Service (NRCS) and California Association of Resource Conservation Districts (CARCD) announce 3rd round grantees of Small Fund Program "Outreach Mini Grants". NRCS California in partnership with CARCD have provided small community outreach fund opportunities for Ag Partners, Non-Profit Organizations and RCD's for resource conservation projects to historically underserved producers. Future fund cycles to be

announced with a maximum fund total of \$2,000.00. The funds may be used to supplement ongoing conservation outreach efforts and do not require a new project be developed. USDA Streamlined Guaranteed Loans and Additional Lender Category for Small-Scale Operators

The U.S. Department of Agriculture (USDA) announced recently the availability of a streamlined version of USDA guaranteed loans, which are tailored for smaller scale farms and urban producers. The program, called EZ Guarantee Loans, uses a simplified application process to help beginning, small, underserved and family farmers and ranchers apply for loans of up to \$100,000 from USDA-approved lenders to purchase farmland or finance agricultural operations.

USDA unveiled a new category of lenders that will join traditional lenders, such as banks and credit unions, in offering USDA EZ Guarantee Loans. Microlenders, which include Community Development Financial Institutions and Rural Rehabilitation Corporations, will be able to offer their customers up to \$50,000 of EZ Guaranteed Loans, helping to reach urban areas and underserved producers. Banks, credit unions and other traditional USDA-approved lenders, can offer customers up to \$100,000 to help with agricultural operation costs.

EZ Guarantee Loans offer low interest rates and terms up to seven years for financing operating expenses and 40 years for financing the purchase of farm real estate. USDA-approved lenders can issue these loans with the Farm Service Agency (FSA) guaranteeing the loan up to 95 percent.

More than half of all FSA loans go to new farmers and more than a quarter to underserved borrowers. FSA also offers loans of up to \$5,000 to young farmers and ranchers through the Youth Loan Program. Loans are made to eligible youth to finance agricultural projects, with almost 9,000 young people now participating. \$8 Million Fund Created to Improve Water Quality and Conserve Greater Sage-Grouse in the Eastern Sierra

The USDA's Regional Conservation Partnership Program (RCPP) has created an \$8 million fund to support initiatives conserving the Bi-State population of greater sage-grouse and enhancing ranch water quality in the region. The \$8 million fund will be available for five years to landowners in portions of Inyo, Mono, and Alpine Counties of California and portions of Douglas, Lyon, Carson City, Mineral, and Esmeralda Counties in Nevada. Ranchers can apply to receive funds from this pool in order to complete projects that will enhance sage-grouse habitat and improve water quality on property they own and manage. NRCS California Offers Post-Flood Assistance; Assessments Underway

In the wake of recent California flooding, the USDA Natural Resources Conservation Service (NRCS) in California is meeting with landowners and other agencies to assess damages and offer technical and financial assistance where possible. Assistance programs through NRCS include the Emergency Watershed Protection Program (EWP) and the Environmental Quality Incentives Program (EQIP).

Watershed Assistance

The program requires local government bodies or others to sponsor on-the-ground work including concrete barriers and streambank protection, mulching, and other damage control measures. Potential sponsors seeking assistance should do so through their local USDA service center <http://offices.sc.egov.usda.gov/locator/app?state=CA>.

Landowner Technical Assistance

NRCS may also be able to provide technical and educational assistance to landowners faced with erosion and flooding in a damaged watershed. Agency conservationists have expertise in erosion, drainage and the use of measures (such as sand bags, mulching etc.) to mitigate damage to the landscape.

Farmer/Rancher Assistance

EQIP can provide long-term support to repair erosion on agricultural lands such as gullies, streams, or hillsides. NRCS takes applications on an ongoing basis throughout the year and encourage interested landowners to contact their local offices for more information. Certified Organic Survey for 2016 Data Collection Now Through Early May

NASS is now conducting the 2016 Certified Organic Survey to gather additional data on acreage, production, and sales for certified organic crops and livestock. Your response is critical to help inform program and policy decisions, such as developing more accurate organic crop insurance coverage provided by USDA's Risk Management Agency. The results of this survey will be available in aggregate form only, ensuring that no individual operation or producer can be identified as required by federal law. How Much Does It Cost to Rent Cropland? Find Out with the Cash Rents Survey

The Cash Rents Survey provides the basis for county estimates of the cash rent paid for irrigated cropland, non-irrigated cropland, and pasture. NASS mailed the Cash Rents survey in February and will continue to collect data until July. The results of this survey will be available online in August. June Hogs Survey Starts Late May

The agency will survey pork producers for detailed information on market hog and breeding stock inventories as well as pig crop and farrowing intentions. NASS will mail the questionnaires to all producers selected for the survey in late May. To ensure all survey participants have an opportunity to respond, NASS interviewers will contact producers who do not respond by mail or online to conduct telephone and personal interviews.
